In compliance to letter under reference the para wise reply of letter  
No. 231037-S/35/IW-2/CO-B/T-3/NAB(K)/2015/1127 dated 23.04.2015 of  
Deputy Director (Coord) for Director IW-2 is submitted as under:-

It is submitted that the land sold out to Malik Shahid Ahmed Khan vide  
registered Sale Deed No. 296 dated 30.12.2010 measuring 1307 acres in  
Makan Khareseer Deh Kohistan 7/4 Tapo Jungshahi Taluka & District  
Thatta is not the same land which was allotted by the Government of Sindh  
Land Utilization Department in favour of Live Stock and Fisheries  
Department vide letter No. 06-303-03/SO-I/586/12 dated 31.07.2012 (copy  
of allotment order is enclosed) measuring 1300-00 acres in Deh Kohistan  
7/4 Tapo Jungshahi Taluka & District Thatta. In fact Makan Khresar is not  
existing in Deh Kohistan 7/4 Tapo Jungshahi Taluka & District Thatta as  
confirmed from Mukhtiarkar Estate Thatta. The location of land sold out to  
Malik Shahid Ahmed Khan is not traced out as such nobody knows about  
the location of this land sold out to about Malik Shahid Ahmed Khan.


Makan Kharesar is not existing in Deh 7/4 Kohistan Tapo Jungshahi Taluka & District Thatta the details of allotments already made in this Makan are not available in this office record as such the entire record has been burnt due to the incident of Shaheed Mohtarma Benazir Bhutto on 27.12.2007 hence this office is unable to provide the same due to non availability of above record however the Mukhtiarkar Estate Thatta may kindly be requested to provide the same as the details of allotments if any made in the above Makan are available on his office record.

The attested copies of the Extract of Record of Rights of Deh 7/4 Kohistan Tapo Jungshahi Taluka Thatta have already been provided by the undersigned however attested copies of the same are once again provided herewith as desired.

In the meanwhile the Government of Sindh Revenue Department through their Notification No. 08/MISC/2015/Rev-I(II)/112 dated 30.04.2015 issued by the Senior Member Board of Revenue Sindh Hyderabad has been cancelled the entire entries of reconstruction of Record of Rights of 56 including Deh 7/4 Kohistan by passing order as under:-

And whereas it appears to the Board of Revenue Sindh that record of rights (VF-VII A) of Taluka Thatta which were reconstructed after burning the previous record during 2007 have not been properly prepared and are full of defects, omissions and also contain fraudulent entries through which Government land has been mutated in the names of private persons. Accordingly the reconstructed VF-VII A of following Dehs of Taluka Thatta are hereby cancelled. It is further directed that Fresh VF-VII A may be reconstructed by the Assistant Commissioner / Assistant Collector of the first grade Thatta for the following Dehs. The copy of the notification is enclosed herewith for kind perusal of the NAB Authorities.

The attested copies of the file maintained by the office of the Assistant Commissioner Revenue Thatta on the above subject pertaining to user Malik Shahid Ahmed Khan is also enclosed herewith.
